WHAT IS ENERGY ASSISTANCE OR LIHEAP?

The Low Income Home Energy Assistance Program (LIHEAP) is a federally funded program for qualified households that provides a one-time benefit (per program year) to assist with heating costs.

Essential Energy Assistance Facts

1. Contact your local Community Action agency to see if you qualify.
2. The financial eligibility requirement must be at or below 60 percent of Oregon's median income (see chart below).
3. Both homeowner and renter households are eligible.
4. There is a one-time benefit per year (program year Oct. 1 - Sept. 30).
5. Participants must re-apply each year (program year Oct. 1 - Sept. 30).
