# Washington Conservation Incentive Program New Home Builder Incentives

#### New Homes

Rebates effective for installs on or after <u>June 30th, 2017</u>. Incentives may be subject to change and are only applicable for tariff approved measures in place at the time of installation.

Condensing High-Efficiency Tankless Water Heater <sup>4</sup>	0.87 + UEF (0.91+ EF)	\$250

### Efficient New Home Packages

ENERGY STAR® Certified Home <sup>183</sup>	National Program Requirements Version 3.1 (Rev. 08)	\$2,000
Built Green Certified Home <sup>183</sup>	Requires Built Green Certification	\$2,000

- 1. Home must be heated by natural gas and an electric heat pump cannot be present. Built Green measures require proof of a natural gas heating system, such as a photo or invoice.
- 2. Pre-approval from CNGC required. Space Heating and Domestic Hot Water heating must be provided through a combination boiler or tankless water heater
- 3. These incentives are only applicable to new homes, not available to existing homes. They may not be combined with any other measure except Hearths (Fireplaces).
- 4. Water-heating fuel must be provided by Cascade Natural Gas for all water-heating incentives.



# Washington Conservation Incentive Program New Home Builder Incentives

### Eligibility Requirements

Rebates effective for installs on or after **June 30th, 2017**. Incentives may be subject to change and are only applicable for tariff approved measures in place at the time of installation.

- New Home and Builder Applications must be received within 6 months of gas service start date.
- Applicant must be a Washington State Cascade Natural Gas customer on residential rate schedules 502 or 503 (see bill).
- Fuel for the home's primary heat source must be provided by Cascade Natural Gas for all heating incentives.
- Customer must not use a heat pump for heating and/or cooling with a natural gas furnace back-up for the furnace,
- combo, door, boiler, and thermostat measures.
- All equipment installation and service measures must be performed by a Washington State licensed contractor.
- Appliances and building materials specified by Washington state code are not eligible for Cascade Natural gas incentives.
- ENERGY STAR homes must be approved by an ENERGY STAR verifier.
- Built Green Homes must present Built Green Certification.

#### How to qualify for Cascade Natural Gas incentives:

- 1. Establish your eligibility. Call 866.626.4479 or visit www.cngc.com/conservation for program requirements.
- 2. Install energy-efficient home improvements. Contact a participating Trade Ally contractor or Washington licensed contractor to install eligible measures. Please visit www.cngc.com/conservation for a list of qualified trade allies.
